

2015 TAXICAB
DRIVER LICENSE – NEW APPLICANT

1. Complete all parts of the attached application, except the “Statutory Declaration”.
2. Contact the licensing office to obtain “Request for Vulnerable Sector Police Check” letter.
3. Apply for a Police Criminal Record Check: by appearing in person at the Brant County Detachment of the Ontario Provincial Police, 28 Mechanic Street, Paris (if you are a resident of Brant County), or for non-residents, at the Police Station where you live.

You must take the “Request for Vulnerable Sector Police Check” letter with you, and identify yourself using two pieces of identification from the attached list, one of which must contain your photograph. Please ensure that your current address is on your identification.

Complete and sign the required form(s) at the Police Station and pay the prescribed fee.

4. Attend in person at the County of Brant, 26 Park Avenue, Burford, to file the application together with the following documents:
 - **Police Criminal Record Check including Vulnerable Sector Check** issued within the previous thirty (30) days;
 - **Ministry of Transportation Driver’s Abstract** issued within the previous thirty (30) days;
 - **Your current valid Class “G” Ontario Driver’s License**;
 - **Proof of Canadian Citizenship, landed immigrant status or a valid Canadian work permit**; and
 - **Letter of employment or potential employment** from the licensed taxicab owner for whom you will be driving.
5. Payment of **\$35.00** by cheque payable to the County of Brant, cash or debit.
6. You will be required to produce these documents and sign the “Statutory Declaration” in the presence of a “Commissioner of Oaths”.
7. You will be photographed at this time in order for your ID card to be processed.
