


New Water and Wastewater Rates Effective May 1, 2021

The County of Brant strives to maintain efficient and cost-effective municipal water and wastewater systems. Funding for operation and maintenance is from fees and charges paid by the consumers of the systems. No money collected for property tax is used to fund the water and wastewater systems.

Historically, water and wastewater rates were set annually. The rate structure consisted of a fixed monthly fee specific to the meter size and a volumetric rate that was the same for each cubic meter of water used as measured by the water meter. Consumers expressed desire for a rate structure that reduces costs, encourages and rewards conservation, and provides opportunity to budget for future years. Details of the 2021 Water and Wastewater Rate Study, which considered these desires, can be found on Engage Brant at Engagebrant.ca/waterratestudy.

The new rate structure is set for a 4-year term from May 1, 2021 to April 30, 2025. This will allow consumers to accurately budget for future years. In the new structure the fixed monthly fee, based on meter size, decreases in each of the four years. The new structure also introduces a humpback volumetric rate, where fees change at certain milestones of monthly water usage. The rates are shown on the reverse side of this flyer and are also available on our website at Brant.ca/waterservices. Savings can be realized by minimizing your monthly water usage.

In addition, to encourage residential consumers to use water wisely, especially during the summer months, a special rate is applied to consumption by residential consumers using more than 45 cubic meters per month from May 1 to August 31 each year.

Example Calculation for a Typical Low Volume Water Consumer:

Consider a consumer with a 5/8" meter who consumes 20 cubic meters.

Monthly Fixed Charges: The fixed charge applies even if you have not used any water. The budgeted fixed costs include meter reading, billing, customer service, repair, and maintenance costs. These costs are incurred whether water is used or not.

Volumetric Charges: These charges are based on water consumption, measured by the water meter. The cost of water used is based on a charge per cubic meter (m³). One cubic meter is equal to 1,000 litres or 220 imperial gallons.

Water Shut-off For an Extended Period

Consumers who go away for extended periods or otherwise will not be using water may request that their water be temporarily turned off. Those consumers will pay 75% of the fixed monthly water charge. The fixed charge applies because certain fixed costs are incurred whether water is used or not.
